We do encourage anyone considering setting up an activity, to speak with us to ascertain if Public Liability insurance would be available should you proceed.

HOUSEKEEPING - MOTOR VEHICLES

The 13th, 14th, and 15th July were a shock to the system for many.

Some of us forgot to insure our vehicle or forgot to add it to our existing policy.

At the risk of repeating ourselves, you MUST keep a copy of VIB's Coverage Summary in your vehicle at ALL TIMES.

In the event of a traffic check you may be required to show:

- Registration book the little red book
- Driver's Licence Under the Act, if a Vanuatu resident for 3 or more months, a Vanuatu Driver's Licence is required
- Insurance Under the Act, third party insurance is compulsory if driving on a public road
- Roadworthy inspection documents and sticker
